



Terms & Conditions for E-Bidding:-

1. Bid Solicitation Documents containing all the terms & condition and other relevant instructions for works can be downloaded from the department and or KPPRA website (www.irrigation.gkp.pk)/(www.kppra.gov.pk).
2. Electronic Bidding shall be carried out on "above / below system" on BOQ / Engineers estimate.
3. All bidders are required to have registration with Khyber Pakhtunkhawa Revenue Authority (KPRA) and Pakistan Engineering Council (PEC) in category CE-04.
4. The bidders shall submit 02% bid security of the estimated cost as mentioned above, in the shape of call deposit (original) along with their bid before closing date and time.
5. Notifications issued by KPPRA pertaining to procurement process from time to time shall be applicable (including for additional security KPPRA Notification No.S.R.O.(14)/Vol:1-24/2021-22, dated 10/05/2022).
6. If the evaluated electronic bid costs of two or more bidders are equal then the successful bidder will be declared through draw/toss.
7. The last date & time for submission of the bid along with relevant documents is 16/08/2022 upto 12:00 PM which will be opened on the same day at 12:30 PM in the office of the undersigned in presence of Contractor or their representatives who wishes to attend.
8. Bid security of 1st, 2nd & 3rd lowest bidders may be retained by the employer till the approval of bids by the competent authority.
9. Funds release depends upon policy of Provincial Government: hence payment will be made accordingly, Bidder / Contractor agreeing with the financial constraints in respect of payment etc are at liberty to participate in the instant E-Bidding as no claim whatsoever will be entertained in this regard.
10. All Govt: Notifications / Rules / Taxes updated from time to time shall be applicable.
