- All Bidders are required to have valid Registration with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act 2018 (Khyber Pakhtunkhwa Act, XXI of 2013)
- The Competent Authority reserves the right to accept/reject any or all bids at any time prior to acceptance of a bid as per Para 47(i) of KPPRA Rules 2014 by assigning cogent reason.
- The interested Firms/Contractors may obtain clarification regarding bid solicitation documents during office hours on any working day from the office of Executive Engineer, Swat Irrigation Division-I, Swat.

Venue of Bids opening is office of the Superintending Engineer, Swat Irrigation Circle Saidu Sharif Swat however, the Contractors must prepare their CDR's i.e. 2% Earnest Money and Additional E/Money (if any) as per KPPRA Notification No.S.R.O (14)/ Vol:1-24/2021-22, dated 10-05-2022, in shape of call deposits only in the name of Executive Engineer, Swat Irrigation Division-I, Swat and should ensure its submission with their bids.
