



Terms & Conditions for E-Bidding:-

- Bid Solicitation Documents containing all the terms and conditions and other relevant instructions for works can be downloaded from the department and or KPPRA websites (www.irrigation.gkp.pk) / (www.kppra.gov.pk).
- Electronic bidding shall be done on "above / below system" on BOQ / Engineer's estimate.
- As per clause 37 (A) KPPRA Rules, All bidder are required to have registration with Khyber Pakhtunkhwa Revenue Authority.
- The bidder shall submit 02% bid security, of the estimated cost as mentioned above, in the shape of Call deposit (Original) along with their bid before closing date and time which must reach to this office through courier service and the authenticity of the envelop will be confirmed from the Courier Service by the Executive Engineer Incharge.
- Notifications issued by KPPRA pertaining to procurement process issued from time to time shall be applicable.
- If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw / toss.
- Pre-bid meeting will be held on 20/7/2022 at 12:30 PM in the office of the Executive Engineer Paharpur Irrigation Division DIKhan.
- The Last date and time for Submission of the Bid along with relevant documents is 21/7/2022 up to 12:00 Noon which will be opened on the same day at 2:00 PM in the office of the undersigned in presence of Contractor and their representatives who wishes to attend.
- Bid security of 1st, 2nd and 3rd lowest bidders will be retained by the employer till the approval of bids by the competent Authority.
- Terms and conditions as per KPPRA act 2014 prevailing notifications or subsequent changes if made therein and whereas matters pertaining to Add: Bid security as per KPPRA SRO No. (14)/VOL-1-24/2021-22 dated 10-05-2022 will be applicable.
- All Govt: Notifications/ Rules/Taxes updated from time to time shall be applicable.
- Required PEC Category CE-04.
- The undersigned reserve the right to reject the bids as per provision containing in rule 47 of KPPRA procurement rules 2014.
