

- 2/ The bidder shall submit their bids through leading courier service on or before the deadline along with required documents as per detail mentioned in bid solicitation documents.
- 3/ Electronic Bid shall be done on "above / below" system on BOQ / Engineers Estimate.
- All the participating firm will be evaluated as per Criteria duly included in Bid Solicitation documents and the firms who failed in the criteria will be considered non-responsive.
- 5/ Venue of Bids opening is office of the Executive Engineer Bannu Canal Division Bannu.
- 6/ If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw/toss.
- Two percent (02%) Bid Security/Earnest Money + Stamp duty of the estimated cost from the account of firm/bidder/contractor who submits the bid must be accompanied with the tender document/contractor through any scheduled bank in favour of Executive Engineer Bannu Canal Division Bannu. Failure to submit the 02% CDR will lead to rejection of the bid.
- The bidders who quote their bids/rates more than 10% below on Engineer's estimate shall submit additional security as per KPPRA Notification No.S.R.O (14)/Vol:1-24/2021-22 dated 10/05/2022.
