1. For the Sub work the bid solicitation documents should be submitted by interested bidders.
2. Electronic bidding will be based on an "above/below system" on BOQ/Engineer's estimate.
3. All bidders must be registered with the Khyber Pakhtunkhwa Revenue Authority.
4. Bidders shall submit 2% bid security of the estimated cost (as mentioned above) in the form of an original deposit-at-call along with their bid before the closing date and time.
5. Notifications issued by KPPRA regarding procurement processes will apply. Relevant notification: S.R.O (14)/Vol:1-24/2021-22, dated 10-08-2022/6058-71.
6. A non-refundable bidding entry fee (0.03% of the tender cost) in the form of a call deposit must be submitted (in original) in the name of the Executive Engineer, Dir Irrigation Division, Dir.
7. In cases where two or more bidders have equal evaluated costs, the successful bidder will be selected based on performance.
8. A pre-bid meeting will be held on **02-01-2025** at 11:00 AM in the office of the Executive Engineer, Dir Irrigation Division, at Timergara Dir Lower.
9. The last date for submission of bids, along with relevant documents, is **07-01-2025** at **2:00 PM**. The bids will be opened on the same day at **2:30 PM** in the presence of bidders.
10. Bid security of the 1st, 2nd, and 3rd responsive lowest bidders will be retained by the employer until the approval of bids by the competent authority.
11. All Government Notifications/Rules/Taxes updated from time to time shall be applicable.
