

2. Electronic bidding shall be done on “Above / Below system” on BOQ / Engineer’s estimate.
3. The bidder shall submit their bids on the following address “Executive Engineer Peshawar Canals Division Peshawar” only through reliable courier Service on or before the deadline along with required documents as per details mentioned in Bid Solicitation Documents. The affixed labels of the Courier Service provider shall be authenticated for tracking before opening. Fake courier delivery shall be processed as per the law and would not be considered.
4. All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority.
5. The bidder shall submit 02% bid security of the estimated cost as mentioned above, in the shape of deposit at call (Original) enclosed along with their bid before closing date and time in the name of Executive Engineer, Peshawar Canals Division, Peshawar.
6. Non-refundable bidding entry fee @0.03% of tender cost in Shape of Call Deposit separately may be furnished (in original) to this office in the name of Executive Engineer, Peshawar Canals Division, Peshawar.
