- Bidding Documents including instruction to bidders, Terms and conditions and Evaluation Criteria can be downloaded from Irrigation Department Website (<u>www.irrigation.gkp.pk</u>) and KPPPRA official Website. for each package separate Bid documents are to be submitted by the interested bidders.
- 2. The bidder shall submit their bids through leading courier service on or before the deadline along with required documents as per detail mentioned in bid solicitation documents.
- 3. Electronic Bid shall be done on "above / below" System on BOQ / Engineer estimate.
- 4. All the participating firm will be evaluated as per Criteria duly included in Bid Solicitation documents and the firms who failed in the criteria will be considered non-responsive.
- 5. Venue of Bids Opening is Executive Engineer Gomal Zam Irrigation Division DIKhan.
- 6. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw / toss.
- 7. Two percent (02%) Bid Security/Earnest Money + Stamp duty + Tender Fee of the Estimated cost from the account of firm/ bidder/ contractor who submits the bid must be accompanied with the tender document / Quotation through any scheduled bank in favor of Executive Engineer, Gomal Zam Irrigation Division, DIKhan. Failure to submit the 2% CDR will lead to rejection of the bid.
- 8. Firm must have successfully completed Solar System i/c Pumping Machinery, Auto Sun Tracker along with accessories, having more than 0.5 cusec discharge in past 3 years list of completed solar tube wells with photographs having coordinates must be attached sales Tax returns, Income Tax returns and Financial audited Balance Sheet to be provided.

- 11. All the bidders / firms must be register with the Khyber Pakhtunkhwa Revenue Authority.
- 12. All the prevailing KPPRA Acts / Rules and other Government Notification will be applicable, issued from time to time.
- 13. Funds release depends upon policy of Provincial Government; hence payment will be made accordingly.

  Bidder / Contractor agreeing with the financial constraints in respect of payment etc are at liberty to participate in the instant E-Bidding as no claim whatsoever will be entertained in this regard.
- 14. The Last date & time for Submission of the Bid along with relevant documents is **05-12-2024** up to 12:00 PM which will be opened on the same day at 12:30 PM in the office of the undersigned in presence of Contractor and their representatives who wishes to attend.
- 15. Qualified representative or preferably engineer of the bidding firm must be present at the time of opening of bids.
- 16. All Government notifications / rules / taxes implemented from time to time shall be applicable.
