MINUTES OF DCSC MEETING HELD ON 12TH NOVEMBER, 2024

A DCSC meeting was held on 12th November, 2024 under the Chairmanship of Secretary to Government of Khyber Pakhtunkhwa Irrigation Department, in the Committee Room of Irrigation Department Peshawar. List of participants is attached.

The meeting started with recitation from the Holy Quran. The Chair welcomed all participants and allowed Director (Tech), PMC to present agenda items to the forum. The following agenda item was presented to the forum: -

The Director (Tech), PMC apprised the forum that technical proposals of following consultancy firms for captioned work were opened in the DCSC meeting held on 06-11-2024 and were forwarded to DCSC sub-committee for evaluation. The committee accordingly evaluated technical proposals and the following position has emerged: -
