- The bidders should submit their E-Bids as per KPPRA Notification No. S.R.O (13)/Vol: 1-24/2021-22/6058-71, dated: 10-05-2022.
- Bid Solicitation Documents containing all the terms and conditions and other relevant instructions for the work
 can be downloaded from the Department and or Khyber Pakhtunkhwa Public Procurement Regulatory

- Bidders shall submit tender form fee (non-refundable) i.e @ 0.03% for each work separately in the shape of call deposit receipt (CDR) in the name of Executive Engineer, Gomal Zam Irrigation Division D.I.Khan.
- 5. All the conditions/instructions given in the bidding documents shall be applicable on all competitive bidders.
- 6. The bids will be valid for one hundred & twenty days (120) from the bids opening.
- 7. The bid security upto 3rd lowest bidder will not be released till approval of tender by the competent authority.
- Call Deposit of Scheduled Banks shall be acceptable. If Call Deposit of non-schedule bank provided than the
 contractor's name will be recommended for debar/blacklist No Bank cheque OR pay order shall be acceptable.
- All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013.
- 10. All the prevailing KPPRA rules / Act and other Government Notifications will be applicable issued from time to time & will become part of bidding documents.
- 11. Electronic bidding shall be done on "Above / Below system" on BOQ/Engineer's estimate.
- 12. - 14. The bidder shall submit 02% bid security of the estimated cost as mentioned above, in the shape of deposit at call (Original) enclosed along with their bid before closing date and time in the name of Executive Engineer, Gomal Zam Irrigation Division D.I.Khan.
