**Terms & Conditions for E-Bidding:-**

- Bidding Documents including instruction to bidders, Terms and conditions and Evaluation Criteria can be downloaded from Irrigation Department Website ([www.irrigation.gkp.pk](http://www.irrigation.gkp.pk)) and KPPRA official Website, for each package separate Bid documents are to be submitted by the interested bidders.
- The bidder shall submit their bids through leading courier service on or before the deadline along with required documents as per detail mentioned in bid solicitation documents.
- Electronic Bid shall be done on "above / below" System on BOQ / Engineer estimate.
- All the participating firm will be evaluated as per Criteria duly included in Bid Solicitation documents and the firms who failed in the criteria will be considered non-responsive.
- Venue of Bids Opening is Executive Engineer Gomal Zam Irrigation Division DIKhan.
- If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw / toss.
- Two percent (02%) Bid Security/Earnest Money + Stamp duty + Tender Fee of the Estimated cost from the account of firm/ bidder/ contractor who submits the bid must be accompanied with the tender document / Quotation through any scheduled bank in favor of **Executive Engineer, Gomal Zam Irrigation Division, DIKhan**. Failure to submit the 2% CDR will lead to rejection of the bid.
- Firm must have successfully completed Solar System i/c Pumping Machinery, Auto Sun Tracker along with accessories, having more than 0.5 cusec discharge in past 3 years list of completed solar tube wells with photographs having coordinates must be attached sales Tax returns, Income Tax returns and Financial audited Balance Sheet to be provided.
- The bidders who quote their bids / rates more than 10% below on Engineer's Estimate shall submit additional security as per KPPRA Notification No. S.R.O (14) / Vol: 1-24/2021-22, dated 10-05-2022.
- Bid security of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest electronic bidder for the specific work may be retained by the Department till one week after issuance of LOA.
