### TERMS AND CONDITIONS

1. Electronic bidding will be online through E-bidding system. Tender form and BOQ can be filled online and downloaded from the official website of Irrigation Department i.e. [www.irrigation.gkp.kp](http://www.irrigation.gkp.kp), moreover a complete set of bid solicitation documents may be obtained by the contractor or their representative having valid authority letter on submission of written application from office of the undersigned on cash payment nonrefundable fees of 0.03% @ of estimated cost otherwise bid submitted without these documents will be considered as non-responsive.
2. Electronic bidding shall be done on "above / below system" on BOQ / Engineer's estimate, based on MRS 2024 (1<sup>st</sup> BI Annual). Only two digits after the decimal point shall be considered for evaluation purpose.
3. All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act, 2018 (Khyber Pakhtunkhwa Act. XXI of 2013).
4. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @ 2% only of Engineer Estimate along with the stamp duty in the name of procuring entity (**through courier**) before closing date and time otherwise it will be considered as non-responsive.
5. If the contractors quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
6. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
7. The Additional Security shall be released to the contractor in four installments i.e. 1<sup>st</sup> installment of 25% to be released upon completion of 25% of the project, 2<sup>nd</sup> installment of 25% to be released upon completion of 50% of the project, 3<sup>rd</sup> installment of 25% to be released upon completion of 75% of the project and the 4<sup>th</sup> installment of 25% to be released after 100% completion of the project.

8. Bid security of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidder will be retained by the procuring entity till approval of the bid by the competent authority.
9. All Federal and Provincial taxes / duties shall be deducted from the bills of the contractors at prescribed rates as per Government Policy issued from time to time.
10. The bidders belonging to newly merged areas of tribal districts shall require to submit exemption certificate regarding Federal & Provincial Taxes / duties etc: from the concerned Federal / Provincial tax authorities on approval of their bids.
11. Any bidder who provided incorrect information shall stand disqualified as per KPPRA Act Section 29 (1) rule (43).
12. Successful bidders should sign the agreement with the Department within Twenty-Eight (28) days after acceptance of bid.
13. Electronic bids will be displayed through online E-Bidding System after 30 minutes of closing time in the presence of bidders / their representative who choose to be present.
14. The procuring entity has the authority to reject any E-bid or all E-bids assigning valid reasons.
15. All the prevailing KPPRA rules / Act and other Govt. notifications will be applicable issued from time to time.
16. Technical and Financial bids if received to the office of the undersigned unsealed will be rejected.
17. Pre-bid meeting will be held on **06-03-2025 at 11:00 AM** in office of the undersigned.
