Terms & Conditions for E-Bidding:-

- All bidders are requested to upload their **Bids (CDR'S & Rate or BID Documents)** and submit through EPADS (<https://kp.eprocure.gov.pk/>) before the mentioned system closing time. Any bid received without uploaded **required documents** (copy of CNIC, Enlistment with Govt: of KP, Pakistan Engineering Council & KPRA) will be treated as **NON-RESPONSIVE**.

2. Electronic Bidding shall be done on “**Above / Below System**” on BOQ / Engineer’s Estimate, based on the MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose
3. The bidders should submit their E-Bids as per KPPRA **Notification No. S.R.O (13)/Vol: 1-24/2021-22/6058-71, dated: 10-05-2022.**
4. The bidder shall submit the sealed bid with requisite documents including 2% Bid Security (or additional security if required) of the estimated cost in the shape of call deposit (original) before closing date and time.
5. Bidders shall submit **tender form fee (non-refundable) i.e @ 0.03%** for each work separately in the shape of call deposit receipt (CDR) in the Swat Irrigation Division –II Matta.
6. All the conditions / instructions given in the bidding documents shall be applicable on all competitive bidders.
7. The bids will be valid for one hundred & twenty days (120) from the bids opening
8. **The bid security upto 3rd lowest bidder will not be released till approval of tender by the competent authority.**
9. Call Deposit of Scheduled Banks shall be acceptable. No Bank cheque **OR** pay order shall be acceptable.
10. Any Bidder who provides incorrect information shall stand disqualified and will be debarred.
11. All the bidders are requested to download the bidding documents from the KPPRA website / Irrigation Department Website: www.irrigation.gkp.pk or EPADS: <https://kp.eprocure.gov.pk/>.
12. Pre-bid meeting will be held on **25/07/2025** in the office of the undersigned **at 12.00 Noon.**
13. All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa **Finance Act 2013 (Khyber Pakhtunkhwa Act No.XXI of 2013)**
14. All the prevailing KPPRA rules / Act and other Government Notifications will be applicable issued from time to time & will become part of bidding documents.
15. The Employer has the authority to reject any bid or all the bids assigning cogent reasons.
