2. The bidders should submit their E-Bids as per KPPRA Notification No. S.R.O (13)/Vol: 1-24/2021-22/6058-71, dated: 10-05-2022.
3. The bidder shall submit the sealed bid with requisite documents including 2% Bid Security (or additional security if required) of the estimated cost in the shape of call deposit (original) before closing date and time.
4. Bidders shall submit tender form fee (non-refundable) i.e @ 0.03% for each work separately in the shape of call deposit receipt (CDR) in the Executive Engineer, Mardan Irrigation Division Mardan.

5. All the conditions / instructions given in the bidding documents shall be applicable on all competitive bidders.
6. The bids will be valid for one hundred & twenty days (120) from the bids opening
7. The bid security upto 3rd lowest bidder will not be released till approval of tender by the competent authority.
