2. The bidders should submit their E-Bids as per KPPRA Notification No. S.R.O (13)/Vol: 1-24/2021-22/6058-71, dated: 10-05-2022.
3. The bidder shall submit the sealed bid with requisite documents including 2% Bid Security (or additional security if required)of the estimated cost in the shape of call deposit (original) before closing date and time.
4. Bidders shall submit tender form fee (non-refundable) i.e @ 0.03% for each work separately in the shape of call deposit receipt (CDR) in the Executive Engineer, Mardan Irrigation Division Mardan.
5. All the conditions / instructions given in the bidding documents shall be applicable on all competitive bidders.
6. The bids will be valid for one hundred & twenty days (120) from the bids opening
7. The bid security upto 3rd lowest bidder will not be released till approval of tender by the competent authority.
