

Machinery)

1. Biding Documents including Tender Forms, BOQ and instructions to Bidders can be downloaded till last day prior to the opening date from Irrigation Department web site (www.irrigation.gkp.pk) or from the E-PADS web site (www.eprocure.gov.pk).

2. Registration with Securities Exchange Committee of Pakistan (SECP) under Companies Act

(under section 32 of the Companies Ordinance, 1998).

3. Electronic Bid shall be done on "above/below" system on BOQ/Engineers Estimate.

4. Valid PEC registration with at least C-5 categories along with specialized codes CE-09, CE-10, EE-03, EE-04, EE-11(Solar), ME-05 (workshop), ME-07 (General Mechanical Works Only) (All Codes are Mandatory).

5. Venue of Bids opening in office of the Executive Engineer Bannu Canal Division Bannu.

6. The Bidders shall submit a Single Envelope (Sealed Bid), which shall contain two separate

sealed envelopes of Financial and Technical Proposals.

7. The Technical Proposal Envelopes of the Bidders, containing CNICs and all required & essential documents/Stamp paper duly attested by Oath Commissioner, shall be opened on the same day of submission of Bids at 2:00 P.M in presence of Contractors or their Firms' authorized representative (Optional). And shall be processed for Technical Scrutiny, those who are found eligible shall be declared Responsive and shall be informed for further opening of their Financial Proposal/Bids.

B. Two Percent (02%) Bid Security of the estimated cost from the account of firm/ bidder / contractor who submits the bid must be accompanied with the tender document issued through any scheduled bank in favor of Executive Engineer Bannu Canal Division Bannu. Failure to submit the 02% CDR will

lead to rejection of bid.

9. The Bid Security and Quoted Rates on the BOQs shall be sealed in the Financial Proposal Envelopes and duly stamped with the Firms/Co: Seals. And a separate Affidavit of Declaration on Stamp-Paper duly attested by Oath Commissioner: shall be provided in the Technical Proposal Envelopes wherein declare that the required amount of Bid Security has been provided in the Financial Proposal Envelopes.

10. Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work may be

retained by the Department till one week after issuance of LOA.

11. The last date & time for submission of the Bid alongwith relevant documents is 26/09/2025 upto 12:00 P.M which will be opened on the same day at 12:30 PM in the office of the undersigned in the present of Contractors or other authorized representatives. If there is an official/Gazetted holiday on the date of opening, then tenders will be opened on the next working day.

12. The Bidders who quote rates more than 10% below up to 20% on BOQ shall Deposit 8%

Additional Call Deposit in addition to 2% bid security.

- 13. The contractor / bidders while quoting their rates shall submit 2% bid security (CDR) and additional security as per KPPRA Notification No. S.R.O(14)/Vol:1-24/2021-22 dated: 10-05-2022.
- 14. All other terms and conditions will be as per KPPRA rules, PEC, SBDs and other relevant laws.
- 15. Govt Taxes shall be applied as prevailing.

16. No bank Guarantees acceptable to this office.

17. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in schedule-II of the Act ibid).

18. Tender Documents/Evaluation criteria are available in the office of the undersigned and can be obtained on any working day during office hours at least three days before the closing

date on cash payment of Rs. 2000/- each (non-refundable).
