




- The scheme was approved by DDWP in its meeting held on 02-09-2025 under the chairmanship of Secretary to the Govt. of Khyber Pakhtunkhwa, Irrigation Department. The minutes of the meeting were circulated vide this department letter No. PMC/DDWP/020925 dated: 08-09-2025.
- The expenditure involved will be met out from the sanctioned budget, chargeable to 04-Economic Affairs, 042 Agricultural, Food, Irrigation, Forestry and 042250-others.
- The Administrative Approval does not constitute any sanction to the design/rates provided in the rough estimates. The Financial responsibility of the design/rates rests with the authority competent to accord technical sanction to the cost estimate.
- The completion date of the scheme will be 30th June, 2027.
- The sanctioning authority shall allow appropriate rates after observing all codal formalities/standing instructions regarding schedule of rates and financial regularity. The work shall be taken in hand after release of funds and issuance of proper technical sanction of the cost estimate by the competent authority. The executing agency shall be responsible to maintain proper record and accounts in accordance with the relevant rules/guidelines/instructions and fulfill all necessary codal formalities.
- The executing agency shall provide certificate that the PC-I/Detailed cost estimates have been designed as per site requirements and scope of work before execution of work.
