The sub work having estimated cost of **Rs.68.42 (Million)** was put to E-tender through **EPADS** and published via **KPPRA & Irrigation** websites and in Daily Newspaper **Mashriq Peshawar, Daily Jiddat & Express Tribune** dated **18-01-2026** vide **INF(P) 258/26**. 3. At closing date & time i.e 04.02.2026 @ 12:00 Noon (08) Envelopes/Bids were received in hard form.
4. On 12:30 P.M Bids of (08) Nos bidder, who have uploaded their bids on EPAD System were considered and opened by the Procurement Committee in the presence of bidder/representative on 12:30 P.M.


