



**BIDS EVALUATION REPORT.**

Name of Work:

**Construction of flood protection works / irrigation channel, check dam and canal patrol roads in Northern Districts of Khyber Pakhtunkhwa (Chitral Lower, Chitral Upper, Swat, Dir Upper, Dir Lower, Malakand, Buner, Shangla, Kohistan Upper, Kohistan Lower, Battagram, Mansehra, Torghar, Abbottabad, Kolai Pallas and Haripur).(ADP No. 2131/251496) (2025-26)".**

Sub Work:

**Construction of Chukyatan irrigation civil channel in District Dir Upper.**

1. The PC-I for the subject ADP scheme was approved at a total cost of **Rs. 6150 (Million)** during the PDWP meeting held on **08/01/2026**. AA and minutes of the PDWP attached with the tender documents.
2. The approved PC-I comprises 36 sub-works falling within the jurisdiction of Dir Irrigation Division Dir with a total financial outlay of **Rs. 884.88 Million**. The subject sub-work "**Construction of Chukyatan irrigation civil channel in District Dir Upper.**" was approved with an estimated cost of **Rs.25.50 Million**. (Abstract of PC-I attached with the tender documents).
3. A duly constituted Procurement Committee for procurement of works, goods and services, notified vide Chief Engineer (North) Notification No. 4074/C-I/KPPRA dated 11-12-2025, convened a meeting under the chairmanship of the Superintending Engineer, Swat Irrigation Circle, Swat, on 15/01/2026 at 02:00 PM. The Committee finalized the mode of procurement and reviewed the NIT and bidding documents. Minutes of the meeting attached with the tender documents).
4. Consequently, the Notice Inviting Bids (NIT) through Single Stage Single Envelope procurement method was advertised on EPADs, published in national dailies vide INF(P) No. 284/26 dated 21-01-2026, and uploaded on Irrigation Department & KPPRA websites. The **closing date for submission of bids was 04/02/2026**. Advertisement and related correspondence attached with the tender documents).
5. A total of 07 (Seven) bidders submitted their bids through the EPADs system. The bids were opened by the Procurement Committee on 04/02/2026 at 02:00 PM in the presence of intending bidders. During bid opening, the names of bidders, presence of bid securities in hard in sealed envelope, and quoted rates were announced.



8. Due to identical lowest bids quoted by (02) bidder at 20% below the Engineer's Estimate, the bids were treated as lowest evaluated responsive bids. In accordance with the relevant provision of the NIT, the lowest bidder was determined through a draw he draw conducted in the presence of the Procurement Committee and the concerned bidders. Consequently, the bid


ed by M/S Tajak Construction Co: village & P/O Chukyatan Tehsil Dir District Upper, quoting 20% below on Schedule as well as Non-Schedule items, amounting to Rs. 1,00,000/-, has been determined as the lowest evaluated responsive bid. Proceeding of Draw attached.

In view of the above, the Procurement Committee unanimously recommends the award of the subject work to M/S Tajak Construction Co: village & P/O Chukyatan Tehsil Dir District Dir Upper, with contract amount of Rs.2,04,00,000/- (Rupees <sup>Twenty</sup> million & four hundred thousand only) @ 20% Below premium, on Schedule items as well as on non-schedule item amounting to against the Engineer Estimated cost Rs. 25.50 (M)


