Invitation For Pre-Qualification of Contractors


Applications for pre-qualification are invited under Rule 16 of KPRA Rules 2014 from interested firms/contractors having valid registration of KPRA, PEC and Provincial Works/Irrigation Department KPK in the required Category and Financial limit for the approved Project under PSDP/ADP as detail below:

1. Proposal shall comprise of, but not limited to, the following:

- a) Letter of intent shall address to the Project Director Remodeling of Warsak Canal System in Peshawar & Nowshera Districts, Irrigation Department Peshawar.
- b) The title page of brochure shall contain the nomenclature of the project for which the contractor / firm intends to apply for pre-qualification.
- c) Updated Brochure/Company profile shall be properly binded (in hard cover)/stapled, each and every page of the brochure shall be numbered, readable, stamped and signed by the owner of the firm.
- d) The Pre-qualification is open to the National & International Constructors / Joint Venture of Constructors. In case of Joint Venture the Lead Firm should be in Category C-2 having valid registration with Pakistan Engineering Council (PEC).
- e) The foreign Constructors / Applicants shall only be considered if they participate in association with local firms in the form of Joint Venture and it shall be mandatory for them to submit with their application, a Letter of Intent to enter into an Agreement and properly registered with PEC as a Joint Venture in case they are awarded the Contract. International Constructor shall obtain NOC from the Pakistan Engineering Council (PEC) for the stated Project.
- f) The Joint Venture with foreign Constructors / Applicants, required to submit affidavit on Judicial Stamp Paper which clearly specify that the Firm (foreign Constructor / Applicant) is active tax payer and not blacklisted from their respective Country.
- g) The firms shall have valid and renewed registration with PEC in the relevant field of specialization and should be enlisted with Provincial Government, Khyber Pakhtunkhwa, Peshawar.
- h) The firms shall be registered with KPRA Khyber Pakhtunkhwa and should be active taxpayer.
- i) Detail of staff (Technical and computing) along with their academic documents, CNICs, and salary evidences since last five years.
- j) Details of similar nature projects, execution of pumps, motors and laying of similar nature pipes in hand / completed by the contractor / firm during last ten (10) years duly supported by the letter(s) of acceptance, work order(s) and the completion certificates, issued by the concerned executing agencies.
- k) Details of relevant machinery for works execution with proof of ownership supported with purchase documents, undertaking for availability of rented machinery on Judicial stamp paper.
- l) Proof of financial soundness of contractor / firm for the last 3 years duly supported by the annual audit reports by external auditors, Bank statement with bank credit line, readable, stamped and signed by the authorized representative of the Bank concerned.
- m) Detail of litigation and arbitration cases (if any) in which the contractor/firm is involved.
- n) The Firm should be an active Income Tax returner with FBR.
- o) The Firm shall submit an affidavit to the effect that all the information furnished by him is correct to the best of his knowledge.
- p) Only firms pre-qualified under this procedure will be invited to bid.
- q) Any Other Document or information which is considered necessary for pre-qualification.

2. A set of pre-qualification documents (including inter alia evaluation criteria, instruction for preparation of firm's brochure and list of documentary evidence required for pre-qualification) be downloaded from official website of Irrigation Department Government of Khyber Pakhtunkhwa i.e. www.irrigation.kpk.pk. The intended contractors/firms must frame their proposals in light of the criteria reflected in these documents.
3. The above pre-qualification document(s) (duly filed and properly sealed) along with the aforesaid pre-requisites, must reach the office of the undersigned through courier, on or before the above-mentioned date and time. By hand submission will not be considered.
