

The bids received late shall not be entertained. Any delay in delivery of quotation documents will be responsibility of the bidders.
3. The bidders are required to send their bids in duplicate in separate envelopes clearly marked as original and duplicate. The technical qualified bidder will be called for financial opening.
4. 2% (Two Percent) earnest Money of the bid cost must accompanied with the financial bid in the shape of call deposit in the name of Executive Engineer Hydrology Irrigation Division Peshawar.
5. The Bidding documents must be signed by an authorized person of the firm.
6. The bid documents received through fax or by hand will not be acceptable.
7. Bid received unsealed shall be rejected.
8. The bidders are required to quoted their/his total bid in figure and words in the bid from of the bidding documents/ financial proposal.
9. Only the first two figures after decimal of the rate will be considered for evaluation of the bid.
10. Bidding documents shall be issued to the original firms or their/his authorized representative.

11. Incomplete/conditional bid shall not be acceptable.
