TERMS AND CONDITIONS.

1. Electronic bidding shall be done on "above / below system" on BOQ/ Engineer's estimate, based on the MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
2. All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act, 2018 (Khyber Pakhtunkhwa Act XXI of 2013).
3. The bidder shall submit through courier 02% bid security on the estimated cost including professional Tax/ Stamp Duty accompany with the bidding documents in sealed envelope of the shape of deposit at call (original) before closing date and time.
4. Matters pertaining to Additional Bid Security will be applicable as per KPPRA notification No. S.R.O(12)/vol.1-20/2020-21 dated:21/04/2021
5. Successful bidders should sign the agreement with the Department within Twenty Eight (28) days after acceptance of bid.
6. If the evaluated electronic bid costs of two or more bidders are equal then the successful bidder will be declared through draw / toss.
7. The employer has the authority to reject any or all Bids assigning cogent reasons.
8. Bid security of 2nd and 3rd lowest bidders will be retained by the employer till the approval of bids.
