### **TERMS & CONDITIONS**

- 1- The Bids shall be submitted electronically through E-Bidding on or before the fixed date / time.
- 2- The bidder shall submit the bids with requisite documents through courier service / postal dak i/c 2% E/Money of the estimated cost + stamp duty in shape of call deposit (original) in sealed envelope before closing date and time.
- 3- The bid/rate quoted by the bidders more than 10% below the Engineer's estimate, the additional bid security shall be deposited by the bidder only to the extent of bid more than 10% below the engineer's estimate in the shape of call deposit. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rate beyond 10% below engineer's estimate within 03 working days from issuance of letter of Acceptance failing which his bid security shall be forfeited in favour of govt: besides initiating legal proceeding against the bidder.
- 4- Tenders shall be opened on fixed date and time (as advertised) in the presence of bidders or their representatives who may like to attend the session. In case of any unforeseen reasons, public holiday, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
- 5- The original and all copies of the bid shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign (Form H shall be attached if applicable). All pages of the bid/ tender documents shall be initialed and official seal be affixed by the person or persons signing the bid.
- 6- The bid security shall be forfeited if a bidder withdraws his bid, with in the validity period thereof or, in the case of a successful bidder, who repudiates the contract.
- 7- All federal and provincial duties /stamp duty /taxes including sales tax will be recoverable as per directives of the government issued from time to time.
- 8- Electronic bids will be valid for Ninety (90) days from the closing date of bids.
- 9- Call Deposit from Scheduled Banks shall be acceptable. No Bank cheque or pay order shall be acceptable.
- 10- If any document submitted along with bid documents found false / bogus the registration of the contractor/ firm shall stands cancelled/black listed.
- 11- Any disfiguring /over writing, manipulation in the tender shall be liable to rejection.
- 12- Only the first two figures after decimal of the rate will be considered for evaluation of the bid.
- 13- Incomplete, conditional and bids without 2% of earnest money shall be considered as non-responsive.
- 14- Payments will be made on availability of funds.
- 15- The work shall not be assigned / Sublette to other contractor / firm by the lowest bidder without written approval of the undersigned otherwise his contract will be rescind and his 2% earnest money will be forfeited in favour of government.
- 16- Receiving bid solicitation documents by the contractors from Divisional Irrigation Office Mardan on payment of Rs.100/- (Non-refundable) upto one day before the opening date of tender is essential.
- 17- In pursuance of Rules 37.A it is compulsory / mandatory for all bidders to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act 2013.
