Rehabilitation/Renovation of Chief Engineer (North) office building and Allied Infrastructure.



- 2 Bid Solicitation Documents were uploaded both on KPPRA and Irrigation Department Websites.
- 3 Single Stage One Envelope Bidding Procedure was adopted.
- 4 For carrying out the procurement process, a committee notified vide Superintending Engineer (HQ-North) Irrigation Department Peshawar Notification No. 2355/C-I/KPPRA dated 15.06.2022 to carry out the procurement process in line with KPPRA Act / Rules.
- 5 The Bids were opened on the given date 15.06.2022 in the office of Executive Engineer Mechanical Irrigation Division Peshawar and in the presence of the contractors and their representatives.
