- 1. For each Package separate Bid solicitation document are to be submitted by the interested Bidders.
- 2. Electronic bidding shall be done on "above / below system" on BOQ / Engineer's estimate.
- 3. The bidder shall submit their Bids on the following address "Superintending Engineer Peshawar Irrigation Circle Peshawar" only through reliable courier service on or before the dead line along with required document as per details mentioned in bid solicitation document. The affixed labials of the courier service provider may be authenticated for tracking before opening. Fake courier delivery shall be processed as per the law and would not be considered.
- 4. All bidders are required to have valid registration with Khyber Pakhtunkhwa revenue authority.
- 5. The bidder shall submit 02% bid security, of the estimated cost as mentioned above, in the shape of deposit at call (Original) along with their bid before closing date and time in the name of Executive Engineer Warsak Canals Division Peshawar.
- 6. Notifications issued by KPPRA pertaining to procurement process issued from time to time shall be applicable.
- 7. BOQ alongwith photo copies of the following i.e Pakistan engineering Council Registration for the year 2023-24, Enlistment with Irrigation Department with renewal for 2023-2024, Registration with Khyber Pakhtunkhwa Revenue Authority, NIC, ownership documents, Income Tax/NTN certificate & other mandatory documents shall be required for bid evaluation / approval purposes of the concerned Firm / Contractor after E-bidding Procedure the bid shall not be considered for evaluation if short coming etc: is detected.
- 8. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw / toss.
