

CANCELLATION OF TENDER NOTICE

The Notice Inviting Tender for the work titled “ADP No. 2276/2214/2109/210665- Rehabilitation/Improvement of Cannals and other Irrigation Infrastructure in Khyber Pakhtunkhwa. Sub Work:- Rehabilitation of Office Buliding/SDO Office, Residential Colony & allied infrastructure of Chitral Irrigation Division” was called for 07.09.2023 vide this office letter No.2317-26/43-M, dated 17.08.2023 which was published in Daily Aaj on 28th of Augut, 2023 vide INF(P)2032/23, dated 28th August, 2023 which was less than the required (15) days from the date of opening of tender/bid submission, which is violation of **Rule 34(1)** and this office has been advised by (KP-PPRA) authority vide his letter No.KPPRA/Discrepancies/13351/2022-23/A16991, dated 28th August, 2023 (received in this office on 07.09.2023) for issuance of Corrigendum/Addendum in the Notice Inviting Tender.

Accordingly the Corrigendum/Addendum in the Notice Inviting Tender were issued by this office vide letter 2488/43-M, datd 07.09.2023 and submitted to Director Information Govt. of Khyber Pakhtunkhwa Peshawar etc as well as to the System (Incharge)/Web Developer, Office of the Secretary to Govt. Irrigation Department Khyber Pakhtunkhwa Peshawar on the same day i.e on 07.09.2023 for the purpose of publication/uploading.

Now the Corrigendum/Addendum in the Notice Inviting Tender published in Aaj Newspaper vide INF(P)2217, dated 11.09.2023 but it was not uploaded on the Web Site of Irrigation Department due to some descripenices pointed out by the Web Developer Irrigation Department and therefore, the Notice Inviting Tender is hereby cancelled.
