

- 2 The work with an Estimated Cost of **Rs.364.78 (Million)** was put to tender after wide publicity through advertisement in the National Dailies / Press vide **INF(P) No.7201/22**, dated **28-12-2022** and was also uploaded through Irrigation Department Website.
- 3 As per scheduled mentioned in the N.I.T conditions tenders were received and opened on **16-01-2023**
- 4 Total **15 No's** Contractors/Firms quoted their bid rates online, however among **15 Nos.** only **08 No.** Firms/Contractors actively participated in the bidding process and produced CDR and other documents.


