## TERMS AND CONDITIONS: -

- 1, Bid Solicitation Documents containing all the terms and conditions and other relevant instructions for the work can be downloaded from the Department and or Khyber Pakhtunkhwa Public Procurement Regulatory Authority websites (www.irrigation.gkp.pk) (www.kppra.gov.pk).
- 2. The bidder shall submit their bids on the address "Office of the Executive Engineer, Irrigation Division Bajaur, Civil Colony Khar Tehsil Khar, District Bajaur" only through reliable courier Service on or before the deadline along with required documents as per details mentioned in Bid Solicitation Documents. The affixed labels of the Courier Service provider shall be authenticated for tracking before opening. Fake courier delivery would not be considered.
- 3. Electronic bidding shall be done on "Above / Below system" on BOQ / Engineer's estimate.
- 4. All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority.
- 5. The bidder shall submit 02% bid security of the estimated cost as mentioned above, in the shape of deposit at call (Original) enclosed along with their bid before closing date and time in the name of Executive Engineer, Irrigation Division Bajaur.
- 6. Notifications issued by Khyber Pakhtunkhwa Public Procurement Regulatory Authority pertaining to procurement process issued from time to time shall be applicable.
- 7. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through toss.
- 8. Any bidder who provides fake information shall stand disqualified and de-barred.
- 9. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of Work Order.
- 10. Electronic Bids validity period is 90-Days.
- 11. Successful bidder shall sign the agreement with the department within Twenty-one (21) days after Issuance of acceptance letter.
- 12. Call deposit of scheduled Banks shall be acceptable.
- 13. The employer has the authority to reject any bid or all the bids assigning cogent reasons.
- 14. Bid security of the 1st, 2nd and 3rd lowest bidders of each work will be retained by the department till the signing of the contract agreement.
- 15. The successful bidder shall be subjected to all admissible taxes including stamp duty, service charges, sales tax and any other at prevailing rates.
- 16. All Govt. Notifications/Rules/Taxes updated from time to time shall be applicable.
- 17. All bidders are required to registered with the Khyber Pakhtunkhwa Revenue Authority (KPRA) established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI or "2013), for works, consulting and non-consulting services as listed in Schedule-II of the act ibid.
- 18.
