- The bid shall comprise of one envelope containing financial bid. All bids received shall be opened and evaluated in the manner prescribed in the bidding document. This shall be the default method of open competitive bidding.
- Electronic bidding shall be done on "above / below system" on BOQ / Engineer's estimate.
- All bidders are required to have registration with Khyber Pakhtunkhwa Revenue Authority (Active Status).
- The bidder shall submit 02% bid security, of the estimated cost as mentioned above, in the shape of call deposit (Original) along with their bid before closing date and time.
- Notifications issued by KPPRA pertaining to procurement process issued from time to time shall be applicable.
- If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through performance base.
- Pre-bid meeting will be held 19-02-2024 at 11:00 AM in the office of the Executive Engineer Tubewell irrigation Division Peshawar.
