- Electronic bidding shall be done on “Above / Below system” on BOQ / Engineer’s estimate.
- The bidder shall submit their bids on the following address “**Executive Engineer, Warsak Canals Division Warsak Road Kababian Peshawar**” only through reliable courier Service on or before the deadline along with required documents as per details mentioned in Bid Solicitation Documents.
- All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority.
- The bidder shall submit 02% bid security of the estimated cost as mentioned above, in the shape of deposit at call (Original) enclosed along with their bid before closing date and time in the name of Executive Engineer, Warsak Canals Division Peshawar.
- The bidder shall also submit 0.03% Non-refundable bidding entry fee of the estimated cost in shape of Deposit at call (Original) enclosed along with their bid before closing date and time in the name of Executive Engineer, Warsak Canal Division Peshawar.
- Notifications issued by Khyber Pakhtunkhwa Public Procurement Regulatory Authority pertaining to procurement process issued from time to time shall be applicable.
- If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw/toss.
- Pre-Bid meeting will be held on 18-07-2024 at 11:00 A.M in the office of Executive Engineer, Warsak Canals Division Peshawar.
- The Tender opening date was 04-07-2024 is hereby canceled due to some technical fault in website. Therefore the last date & time for re-submission of the Bid along with relevant documents is 29-07-2024 upto 12:00 P.M which will be opened on the same day at 12:30 P.M in the office of Executive Engineer, Warsak Canals Division Peshawar in presence of Contractors and their representatives who wishes to attend.
