## Terms & Conditions for E-Bidding:-

- 1. Bidding Solicitation Documents including instruction to bidders, can be downloaded from Irrigation Department Website (<a href="www.irrigation.gkp.pk">www.irrigation.gkp.pk</a>) and KPPPRA official Website, Bid documents are to be submitted by the interested bidders.
- 2. The bidder shall submit their bids through leading courier service on or before the deadline along with required documents as per detail mentioned in bid solicitation documents.
- 3. Electronic Bid shall be done on "above / below" System on BOQ / Engineer estimate.
- 4. Venue of Bids Opening is Executive Engineer Gomal Zam Irrigation Division DIKhan.
- 5. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw / toss.
- 6. Two percent (02%) Bid Security/Earnest Money + Stamp duty + Tender Fee of the Estimated cost from the account of firm/ bidder/ contractor who submits the bid must be accompanied with the tender document / Quotation through any scheduled bank in favor of Executive Engineer, Gomal Zam Irrigation Division, DIKhan. Failure to submit the 2% CDR will lead to rejection of the bid.
- 7. The bidders who quote their bids / rates more than 10% below on Engineer's Estimate shall submit additional security as per KPPPRA Notification No. S.R.O (14) / Vol. 1-24/2021-22, dated 10-05-2022.
- 8. Bid security of the 1<sup>st</sup>, 2<sup>nd</sup> and 3rd lowest electronic bidder for the specific work may be retained by the Department till one week after issuance of LOA.
- 9. All the bidders / firms must be register with the Khyber Pakhtunkhwa Revenue Authority.
- 10. All the prevailing KPPRA Acts / Rules and other Government Notification will be applicable, issued from time to time.
- Funds release depends upon policy of Provincial Government; hence payment will be made accordingly. Bidder / Contractor agreeing with the financial constraints in respect of payment etc are at liberty to participate in the instant E-Bidding as no claim whatsoever will be entertained in this regard.
