As per rules 19 (1&2) of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014 (Rules) states that all the procuring entities shall public/ upload their advertisement on KPPRA web site, (rules available and can be down loaded from the KPPRA website.

Swabi Irrigation Division-I Swabi, Government of Khyber Pakhtunkhwa intends Technical and Financial Electronic Bids on the basis of “single stage single envelop system” with post Qualification method, Rules 17 of KPPRA Rules 2014, for which bids are invited from the eligible Government Contractors / Firms enlisted with the Irrigation Department who have renewed their enlistment and valid PEC license for solar system in the relevant category for the year 2024-25 for the following works.

TERMS AND CONDITIONS:

1. The interested Contractors / Firms are required to provide Technical Proposal comprising information regarding Experience, Personnel Capabilities, Financial Status, Equipment Capabilities and other relevant information as explained in the Bid Soliciting Documents along with 2% call deposit, Additional security (if applicable) and BOQ showing Sales Tax bifurcation details (duly filled) (received vide KPPRA Notification No.S.R.O (10)/Vol:1-18/2020, dated 10/02/2021) provided in the bidding documents, In case of its non-submission, bids would be considered as Non-responsive. These documents must reach on or before 25/09/2024 before 12.00 Noon.
2. Financial Bids shall be submitted electronically through **E-Bidding System of Irrigation Department**.
3. Bid Solicitation documents including Instructions to Bidders, Technical Evaluation Criteria, advertisement for Notice Inviting Bids and required forms to be filled by the bidders can be downloaded from Irrigation website [http://www.irrigation.gkp.pk/as well as KPPRA websitehttp://www.kppra.gov.pk/](http://www.irrigation.gkp.pk/as_well_as_KPPRA_websitehttp://www.kppra.gov.pk/) otherwise. Bids submitted without these documents (Duly filled, each page signed & stamped) will be considered as non-responsive.
4. Venue of Bids Opening is Swabi Irrigation Division-I Swabi at Gohati.
5. The qualification of the lowest bidders shall be checked to ensure whether or not the bidder is qualified to perform the works. If the lowest bidder is not found to be qualified on all the post-qualification criteria provided in the bidding documents, its bid shall be rejected. Credentials of the next lowest bidder shall then be checked against all of the post-qualification criteria provided in the bidding documents, and the contract shall be awarded to the lowest evaluated responsive qualified bidder.
6. All KPPRA rules shall be applicable issued from time to time regarding procurement of works.

7. The KPPRA notification No.S.R.O (14)/Vol:-1-24/2021-22/6058-71 dated 10.5.2022 shall be applicable. The notification can be down loaded from the KPPRA website as well as the notification & date has been made part of the Standard Bidding Documents.
8. The KPPRA notification No.S.R.O (15)/Vol:-1-25/2022-23/6301-13 dated 12.8.2022 shall be applicable. The notification can be down loaded from the KPPRA website.
9. The bids shall be quoted on “%age Above /Below System” on BOQ/ Engineer’s Estimate.
10. The Competent Authority reserves the right to accept/reject any or all bids at any time prior to acceptance of a bid as per Para 47(i) of KPPRA Rules 2014.
11. Call Deposits of only scheduled Banks shall be acceptable. **No Bank Cheque or Pay Order shall be acceptable.**
12. All the Contractor/ Firms shall pay all Govt: taxes including Income Tax, Sales Tax, Professional Tax, Stamp duty etc as per Govt: notifications circulated from time to time.
13. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority (KPRA).
14. Bid Securities and additional securities of the 1st, 2nd & 3rd lowest responsive bidders would be retained till finalization/signing of Contract Agreement with the lowest responsive bidder.
15. Pre -Bid meeting would be held in the office of the undersigned on 19.09.2024 at 11.00 AM.
16. Sealed Technical and financial bids should reach to the O/O the undersigned through courier service before 12.00 Noon on 25.09.2024. Both the bids shall be opened on the same date i.e 27.09.2024 in presence of contractor or their representatives who are required to ensure their presence.
17. Any further information regarding the above tenders can be obtained from office of the undersigned on any working day during office prior to bid opening date.
