



2. The work was put to tender through wide publicity in the National News-Paper through Director, Information Department as per provision under the KPPRA rules. The Advertisement was also displayed / uploaded on the procuring entity website www.irrigation.gkp.pk as well as KPPRA.
3. Technical and Financial (Electronic Bid) were called on Single Stage Two Envelopes System of KPPRA Rules 2014.
4. Bid soliciting documents together with instruction to bidders & BOQ were uploaded on the Irrigation Department Website for downloading by the intending bidders.
5. On stipulated date and time i.e. 19/12/2023 in the office of the Executive Engineer, Irrigation Division, District Bajaur, sealed envelopes comprising Technical & Financial Proposal of the following firm / bidder were received.
6. As per schedule time mentioned in the E-bidding System, Sealed envelopes comprising of Technical Proposals were opened on 19/12/2023 in the presence of the Bidder, Firm and their representatives, who cared to attend and were kept in order the sealed envelopes of Financial Bid separately.


