

TERMS AND CONDITIONS

The affixed labels of the Courier Service provide shall be authenticated for tacking before opening. Fake courier delivery shall be processed as per the law and would not be considered.
4. All bidders are required to be registered with Khyber Pakhtunkhwa Public Procurement Authority.
5. The bidder shall submit 02% bid security of the estimated cost as mentioned above, in the shape of deposit at call (Original) enclosed along with their bid before closing date and time in the name of Executive Engineer, Peshawar Canals Division Peshawar.

6. Non-refundable bidding entry fee @0.03% of the estimated cost in shape of Call Deposit separately may be furnished (in Original) to this office in the name of Executive Engineer, Peshawar Canals Division Peshawar.
7. Notifications issued by Khyber Pakhtunkhwa Public Procurement Regulatory Authority pertaining to procurement process issued from time to time shall be applicable.
