TERMS AND CONDITIONS:

1. Each & every page of bid documents should be numbered & signed.
2. Bid Solicitation documents including Instructions to Bidders can be downloaded from Irrigation website <http://www.irrigation.gkp.pk/> as well as KPPRA website, otherwise bids submitted without these documents (duly filled) will be considered non-responsive.
3. Bid Solicitation documents issued to the bidders, contains requirements for eligible bidder and other important terms and conditions.
4. Electronic Bidding shall be done on "Above / Below System" on BOQ / Engineer's Estimate, based on the MRS/NSI where applicable. Only two digits after the decimal point shall be considered for evaluation purposes.
5. The Bidders should submit their E-Bids through EPADS as per KPPRA Notification No SRO (23)/Vol/1-34/2024-25 Dated 24-03-2024.
6. The Bidder should submit through courier 02% Bid Security sealed in envelope of the estimated cost in the shape of Call Deposit (Original) as per KPPRA instructions, rules and other government notifications issued from time to time.
7. Tender form Fee (non –refundable) @ 0.03% of the estimated Cost in the shape of call deposit separately should be accompanied with tender, If any bidder who failed to submit Tender form Cost and 2% Bid Security before opening of bids will be considered as no responsive, the employer has the authority to reject any bid or all the bids as per Para 47(i) of KPPRA Rules 2014.
8. Bid security of the 1st, 2nd and 3rd lowest Electronic Bidder for the specific work will be retained by the department for one week after issuance of letter of acceptance to the successful bidder. Legible scanned copy of bid security shall be submitted electronically along with the bid on EPAD System.

9. All the bidders / Firms must be registered with the Khyber Pakhtunkhwa Revenue Authority.
10. The contractors quoting their bids more than 10% below upto 20% below on Engineers Estimate shall submit along with their bids 8% Additional security of Engineers estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as nonresponsive.
11. If a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineers estimated cost equal to the differential amount of submitted bid on Engineers estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis or required amount of additional security, then the bid shall be considered non responsive . all the securities submitted along with such nonresponsive bid shall be forfeited in favor of the government and the 2nd lowest bidder and so on will be considered accordingly.
And After opening of technical bids, the detail scrutiny of documents of the bidders will be carried out, the of the following mandatory hard copies of the following documents, the bid will be non responsive and straight mandatory hard copies of following documents must be attach with the bid, if the bidder fails to submit any way will be rejected. I) CNIC Copy of the bidder. II) Valid PEC Registration of Bidder. III) Valid Enlistment Certificate from Works Department. IV) FORM H In case of Companies. V) Valid KPRA Online verification form VI) Valid FBR online verification form VII). The bidder will provide the certificate on Affidavit that firm is not involve in any Litigation case with Irrigation Division Mansehra. The bidder will provide a certificate on Affidavit that he has not been served with any notice w.e.f January 2023 to June, 2025 by this Office regarding slow Progress / below specification or stoppage of execution of Public Works. VIII) The bidder will provide the certificate on Affidavit that no any recovery has been made by any investigation Agency from last 3 years.
12. Pre-bid meeting will be held on 04-12-2025 at 11.00 PM in the office of Executive Engineer, Mansehra Irrigation Division Mansehra.
13. All the bidding will be through E-bidding EPADS system. Technical & Financial bids should be in sealed envelopes clearly marked "Technical Bid & Financial Bid" and shall be submitted through courier before closing time. Any bidder who failed to submit CDR and bidding fee before opening of bids will be considered as no responsive. The Call Deposits / Additional Security of all the contractors will be retained till approval of the tenders by the tender approving authority. Govt: Taxes Shall be applied as prevailing and others terms and conditions are as per KPPRA rules, PEC, SBDs and other relevant laws.
