- All bidders are requested to upload their Bids (CDR'S & Rate on BOQ / BID Documents along-with relevant documents in one PDF file) and submit through EPADS (<https://kp.eprocure.gov.pk/>) before the mentioned system closing time. Any bid received without uploaded required documents i.e (copy of CNIC, Enlistment with Govt. of KP, Pakistan Engineering Council, Active KPRA status & Active FBR status and rate analysis if required) will be treated as NON-RESPONSIVE. Incomplete / conditional bids with un-attested cutting / overwriting / dis-figuring uploaded shall be considered as NON-RESPONSIVE. No hard form / print out of bid are required / acceptable except CDR / Call Deposit.
- Electronic Bidding shall be done on "Above / Below System" on BOQ / Engineer's Estimate, based on the MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
- The bidders should submit their E-Bids as per KPPRA Notification No. S.R.O (13)/Vol: 1-24/2021-22/6058-71, dated: 10-05-2022.
- The bidder shall submit the sealed envelope only including 2% Bid Security (or additional security if required) of the estimated cost in the shape of Call Deposit (original) before closing date and time.
- All the conditions / instructions given in the bidding documents shall be applicable on all competitive bidders.
- The bids will be valid for one hundred & twenty days (120) from the bids opening
- The bid security upto 3rd lowest bidder will not be released till approval of tender by the competent authority.
- Call Deposit of Scheduled Banks shall be acceptable. Bank cheque OR Pay Order & (2%) in the shape of Bank guarantee shall not be acceptable.
- Any Bidder who provides incorrect information shall stand disqualified and will be debarred.
