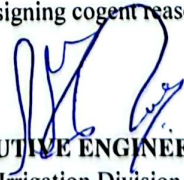

1. All bidders are requested to upload their Bids (CDR'S & Rate or BID Documents) and submit through EPADS (<https://kp.eprocure.gov.pk/>) before the mentioned system closing time. Any bid received without uploaded required documents will be treated as NON-RESPONSIVE.
2. The bidders should submit their E-Pads as per KPPRA Notification No. SRO (13)/Vol: 1-24/2021-22/6058-71. dated: 10-05-2022.
3. Bid Solicitation Documents containing all the terms and conditions and other relevant instructions for the work can be downloaded from the Department and or Khyber Pakhtunkhwa Public Procurement Regulatory Authority websites (www.irrigation.gkp.pk) (www.kppra.gov.pk)
4. Bidders shall submit tender form fee (non-refundable) i.e @ 0.03% for each work separately in the shape of call deposit receipt (CDR) in the name of **Executive Engineer, Gomal Zam Irrigation Division D.I.Khan.**
5. The bids will be valid for one hundred & twenty days (120) from the bids opening.
6. All the conditions/instructions given in the bidding documents shall be applicable on all competitive bidders.
7. The bid security upto 3rd lowest bidder will not be released till approval of tender by the competent authority.
8. Call Deposit of Scheduled Banks shall be acceptable. If Call Deposit of non-schedule bank provided than the contractor's name will be recommended for debar/blacklist No Bank cheque OR pay order shall be acceptable.
9. All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013).
10. All the prevailing KPPRA rules/Act and other Government Notifications will be applicable issued from time to time & will become part of bidding documents.
11. Electronic bidding shall be done on "Above/Below system" on BOQ/Engineer's estimate.
12. The bidder shall submit their bids documents on the following address "**Executive Engineer, Gomal Zam Irrigation Division D.I.Khan**" only through reliable courier Service on or before the deadline. The affixed labels of the Courier Service provider shall be authenticated for tracking before opening. Fake courier delivery shall be processed as per the law and would not be considered.
13. All bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority.
14. The bidder shall submit 02% bid security of the estimated cost as mentioned above, in the shape of deposit at call (Original) enclosed along with their bid before closing date and time in the name of **Executive Engineer, Gomal Zam Irrigation Division D.I.Khan.**
15. The bidder shall submit the sealed bid with requisite documents including 02% Bid Security (or additional security, if required) of the estimated cost in the shape of call deposit (original) before closing date and time.
16. Notifications issued by Khyber Pakhtunkhwa Public Procurement Regulatory Authority pertaining to procurement process issued from time to time shall be applicable.
17. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through toss.
