TERMS AND CONDITIONS FOR E-BIDDING:-

- 1/ Bidding documents including instruction to bidders, Terms and conditions and Evaluation Criteria can be downloaded from Irrigation Department website (www.irrigation.gkp.pk) and KPPRA official website, for each package separate Bid documents are to be submitted by the interested bidders.
- 2/ The bidder shall submit their bids through leading courier service on or before the deadline along with required documents as per detail mentioned in bid solicitation documents.
- 3/ Electronic Bid shall be done on "above / below" system on BOQ / Engineers Estimate.
- 4/ All the participating firm will be evaluated as per Criteria duly included in Bid Solicitation documents and the firms who failed in the criteria will be considered non-responsive.
- 5/ Venue of Bids opening is office of the Executive Engineer Bannu Canal Division Bannu.
- 6/ If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw/toss.
- 7/ Two percent (02%) Bid Security/Earnest Money + Stamp duty of the estimated cost from the account of firm/bidder/contractor who submits the bid must be accompanied with the tender document/contractor through any scheduled bank in favour of Executive Engineer Bannu Canal Division Bannu. Failure to submit the 02% CDR will lead to rejection of the bid.

The bidders who quote their bids/rates more than 10% below on Engineer's estimate shall submit additional security as per KPPRA Notification No.S.R.O (14)/Vol:1-24/2021-22 dated 10/05/2022.

- 9/ Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific will may be retained by the Department till one week after issuance of (LOA) letter of acceptance.
- 10/ All the bidders/firms must be registered with the Khyber Pakhtunkhwa Revenue Authority.
- 11/ All the prevailing KPPRA Acts/Rules and other Government Notification will be applicable, issued from time to time.
- 12/ Funds release depends upon policy of Provincial Government, hence payment will be made accordingly. Bidder/Contractor agreeing with the financial constraints in respect of payment etc: are at liberty to participate in the instant E-bidding as no claim what so ever will be entertained in this regard.
- 13/ Pre-bid meeting will be held on 01/06/2026 at 12:00 PM in the office of the undersigned.
- 15/ All Government Notification/Rules/Taxes implemented from time to time shall be applicable.
- 16/ Any further information regarding the above tender can be obtained from office of the undersigned on any working prior to bid opening date.
- 17/ The employer has the authority to reject any bid or all the bids, assigning cogent reasons.
