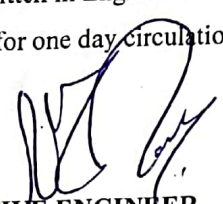

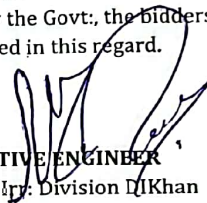

Terms & Conditions:-

- All bidders should upload their Bids (CDR'S, Rate and BID Documents) and submit through EPADS (<https://kp.eprocure.gov.pk/>) before the mentioned system closing time.
- Bid Solicitation Documents containing all the terms and conditions and other relevant instructions for the work can be downloaded from the Department or Khyber Pakhtunkhwa Public Procurement Regulatory Authority websites (www.irrigation.gkp.pk) (www.kppra.gov.pk).
- Technical Design should be based on Hydraulic Parameters of the Scheme provided in the Bidding documents and rates should be quoted accordingly in the Financial Bid. Technical Bid should be in sealed envelope clearly marked "Technical Bid".
- The firm/company shall be the **manufacturer or producer or shall be duly authorized by the respective manufacturer or producer to supply the Solar Panels, Solar Pumping Inverters, Pumps, and Motors of the quoted make and model.** In case the bidder is not the manufacturer or producer, it shall furnish a valid Manufacturer's Authorization Certificate along with relevant purchase history and/or import documents. All offered goods shall confirm to the approved specifications notified by the Government of Khyber Pakhtunkhwa.
- Firm must have successfully completed "Solar System i/c Pumping Machinery, Auto Sun Tracker along with accessories, having more than 0.5 cusec discharge in past 5 years also must be attached sales Tax returns, Income Tax returns and Financial audited Balance Sheet" (As appropriate).

6. All the conditions/instructions given in the bidding documents shall be applicable on all competitive bidders.
7. The bids will be valid for (90-days) from the bids opening.
8. All the prevailing KPPRA rules / Act and other Government Notifications will be applicable Issued from time to time.
9. Electronic bidding shall be done on "Above / below system" on BOQ/Engineer's estimate.
10. The Last date & time for Submission of the Bid along with relevant documents is **30-07-2026** up to 12:00 PM, Technical Bid will be opened on the same day at 01:00 PM in the office of the undersigned in presence of Contractor / Firms and their representatives who wishes to attend and date of Financial Bid of Technically qualified bidders will be announce through EPADS.
11. Pre-bid meeting will be held on **23-07-2026 at 2:00 PM** in the office of the Executive Engineer Gomal Zam Irrigation Division DIKhan.
12. The Bidder shall submit their bids through leading courier services on or before the deadline along with required documents as per detail mentioned in bid solicitation documents.
13. The bidder shall submit 02% bid security of the estimated cost as mentioned above, in the shape of Deposit at call (Original) enclosed along with their bid, (or additional security if required) before closing date and time in the name of **Executive Engineer, Gomal Zam Irrigation Division DIKhan.**
14. As per Notification issued by KPPRA vide No. S.R.O (29)/Vol: 1-40/2025-26 dated Peshawar the October 29,2025/699-711.
 - i. The procuring entity shall retain the original bid security and additional security instrument of all bidders until signing of the contract with the best evaluated bidder or till the bid validity period whichever is earlier.
 - ii. In case of failure to submit the original bid security and additional security instrument before the date and time, the procuring entity shall debar the bidder for a period of one (01) year.
 - iii. In the case of violation for the second time, blacklist him for a minimum period of three (03) years in accordance with section 29 of the KPPRA act read with Rules 44 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014.
15. The Employer has the authority to reject any bid or all the bids assigning cogent reasons.
16. Keeping in view of the current financial constraint & release of funds policy by the Govt., the bidders are at liberty to participate or not in the instant bidding process, as no claims will be entertained in this regard.
