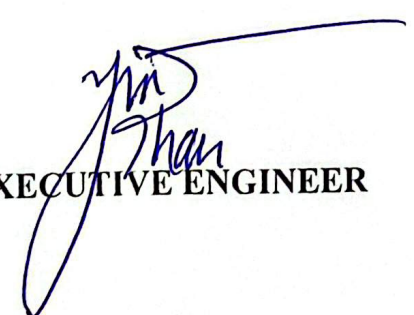

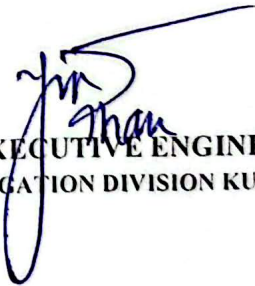

TERMS AND CONDITIONS

1. Last date & time for submission of Technical and Financial Proposals is **23.09.2026 12:00 Noon**, and the Technical Proposal will be opened on the same day at 12:30 PM.
2. Bid Solicitation Documents alongwith the bidding criteria and instruction to bidders and Terms & Conditions can be downloaded from official EPADS, Irrigation Department website (www.irrigation.gkp.pk) and KPPRA website (kppra.gov.pk).
3. Bidders shall be required to submit an affidavit on stamp paper and place the same affidavit in the Technical Proposal, affirming that the CDR, attested copy of PEC registration, CNIC, NTN, and KPPRA Registration enclosed in the sealed financial bid is authentic and original, through registered courier, so as to reach the office of the undersigned on or before the fixed date and time as mentioned above and also uploaded on EPADS. Other-wise the bid will be considered as non-responsive.
4. For Additional Security in case of abnormally low bids KAPRA Notification S.R.O (14)/Vol:1- 24/2021-22, Dated: 10-05-2022 shall be enforced.
5. Bid Security of all bidders would be retained by the procuring entity till approval of the bid by the competent authority.
6. Any bidder who provided incorrect/fake information shall stand disqualified as per KPPRA Act, Section 29(1) Rule (43).
7. A copy of the Technical Proposal as well as Financial securities in the required format is mandatory and uploaded on EPAD System.
8. For Additional Security in case of abnormally low bids KAPRA Notification S.R.O (14)/Vol:1- 24/2021-22, Dated: 10-05-2022 shall be enforced.
9. Pre-bid meeting will be held on **09.09.2026** in the office of the undersigned.
10. Bid will be valid for 120 Days.
11. Separate Broacher/Technical Proposals for each package alongwith required documents shall be submitted clearly mentioning the package name.
12. The Financial Bid will be opened after the approval of Technical Bids from the Competent Authority.
13. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through toss.
14. As Per KAPRA Notification S.R.O (29)/Vol:1-40/2025-26, Dated: 29-10-2025, all conditions of the notification regarding debarred and blacklisting would be applicable.
15. All the prevailing KPPRA rules/Act and other Government notifications issued from time to time shall be applicable.
16. Bid shall be accompanied with 0.03% of Estimated Cost as tender entry fee in a shape of separate CDR which is non-refundable. Non submission would lead to bid rejection.
17. The procuring entity has authority to reject any bid or all bids assigning valid reasons.
