

**Terms & Conditions for E-Bidding:-**

1. All bidders are requested to scan & upload their Bids (CDR'S & Rate on BOQ / BID Documents along-with relevant documents in one PDF file) and submit (in accordance with EPADS Regulations-2025), through EPADS before the mentioned system closing time. Any bid received without uploaded required documents i.e (copy of CNIC, Enlistment with Govt: of KP, Pakistan Engineering Council, Active KPPRA status & Active FBR status and rate analysis (if required) will be treated as NON-RESPONSIVE. Incomplete/conditional bids with unattested cutting/overwriting/disfiguring uploaded shall be considered as NON-RESPONSIVE. No hard form / print out of bid are required / except CDR/call deposit.
2. Bid solicitation documents for the bidders contains requirement for the eligible bidders and other important terms and conditions. Bid solicitation documents i/c instructions to bidders can be downloaded from Irrigation website <http://www.irrigation.gkp.pk/> as well as KPPRA website.
3. Complete detail of bid security in shape of CDR i.e Bank Name, CDR number(s)/ date(s) prepared in the name of Executive Engineer Mardan Irrigation Division, Mardan must be submitted electronically along with E-bid on the EPADS as well as in sealed envelope as per KPPRA notification No.S.R.O (14)/Vol:-1-24/2021-22/6058-71, dated: 10.5.2022 & Notification No.S.R.O (29)/Vol: 1-40/2025-26/699-711 dated 29.10.2025, failure to submit the original bid security CDR and additional CDR (if applicable) in hard form within the stipulated time shall render the bid non-responsive and shall attract penal action, including debarment for a period of one (01) year, after due process. No Bank cheques or pay order shall be accepted.
4. Electronic bidding shall be done on "above/below system" on BOQ/ Engineer Estimate based on the MRS / NSI where applicable. Only two digits after the decimal points shall be considered for evaluation purpose.
5. All the bidders/Firms must be register with the Khyber Pakhtunkhwa Revenue Authority. In case of same rates quoted by the contractors, the lowest bidder shall be decided through draw.
6. All the prevailing KPPRA Acts/ rules/ updated instructions/ notification and other Govt: notifications will be applicable issued from time to time.
7. All the Contractor/ Firms shall pay Govt: taxes including Income Tax, Sales Tax, Professional Tax, Stamp duty etc as per Govt: notifications circulated from time to time.
8. Successful bidder should sign the Agreement with the Deptt: within 28 days after receipt of acceptance letter.
9. The additional security shall be released to the contractor in 04 installment i.e 1st installment of 25% to be released upon completion of 25% of the project and 4<sup>th</sup> installment of 25% upon completion of 50% of the project. 3<sup>rd</sup> installment of 25% upon completion of 75% of the project and 100% completion / handing over the project.
10. All such efforts conspire to curtain making shall be considered as violation of rules 44 and shall be attributed toward mis-procurement under rule 54 procurement rules.
11. Pre-bid meeting will be held on **02.02.2026 at 11.00 AM** in the office of the undersigned.
12. The employer has the authority to reject any bid/ all the bids by assigning cogent reasons.
