**Terms & Conditions for E-Bidding:-**

- All bidders are requested to upload their Bids (CDR'S & Rate or BID Documents) and submit through EPADS (<https://kp.eprocure.gov.pk/>) before the mentioned system closing time. Any bid received without uploaded required documents will be treated as NON-RESPONSIVE.
- Bid Solicitation Documents contains mandatory requirements to be fulfilled in order for bidder to be eligible to participate. The Bidders are required to agree to all terms and conditions of bidding documents.
- The Bidder shall submit their bids through leading courier service on or before the deadline along with required documents as per detail mentioned in the bid solicitation documents.
- The bidder are required to quote their rates above or below on BOQ both on MRS as well as Non MRS components.
- 02% Bid security / Earnest Money + Stamp duty of the estimated cost from the account of firm / bidder / contractor who submit the bid must be accompanied with the tender document/ quotation through any scheduled bank in favor of Executive Engineer, Paharpur Irrigation Divn:DIKhan. Failure to submit the 2% CDR will lead to rejection of the bid
- Call Deposit of Scheduled Banks shall be acceptable. If Call Deposit of non-schedule bank provided than the contractor's name will be recommended for debar/blacklist No Bank cheque OR pay order shall be acceptable.
- The bidders who quote their bids / rates more than 10% below on Engineer's Estimate shall submit along with their bids additional security as per KPPRA Notification SRO No. (14)/VOL-1-24/2021-22 dated 10-05-2022
- If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw / toss.
- The employer has the authority to reject any or all the bids assigning cogent reasons.
- Bid security of 1st, 2nd and 3rd lowest bidders will be released after approval of tender by the competent authority.
- As per clause 37 (A) KPPRA Rules, All bidder are required to have registration with KPK Revenue Authority.
- All the prevailing KPPRA Acts/ Rules and other Govt Notification will be applicable, issued from time to time.
- Funds release depends upon policy of Provincial Govt, hence payment will be made accordingly. Bidder/ Contractor agreeing with the financial constraints in respect of payment etc are at liberty to participate in the instant E-Bidding as no claim whatsoever will be entertained in this regard.
- All Govt: Notifications/ Rules/Taxes updated from time to time shall be applicable.
- The work quantity may decrease due to financial constraints or as the case maybe.
