



1. All bidders are requested to scan & upload their Bids (CDRs) & Rate BOQ/Bid documents along with relevant documents in one PDF file) & submit through EPADS (<https://kp.eprocure.gov.pk/>) before the mentioned system closing time. Any bid received without uploaded required documents i.e. (valid of CNIC, Enlistment with Govt; of KP, valid Registration of Pakistan Engineering Council, Active KPRA status & Active FBR status and rate analysis (if required) will be treated as Non-Responsive. Incomplete/conditional bids with unattested cutting/overwriting/disfiguring uploaded shall be considered as NON-RESPNSIVE. No hard form/print out of bid are required/acceptable except CDR/Call Deposit.
2. Bid solicitation documents fort the bidders contains requirement for the eligible bidders and other import Terms & Condition. Bid solicitation documents i/c instructions to bidders can be downloaded from Irrigation website <http://www.irrigaqtion.gkp.pk/> as well as KPPRA website, Mandatory conditions as solicitation bidding documents (SBDs) will be adhered.
3. Complete detail of bid security in shape of CDR i.e. Bank Name, CDR numbers(s)/date(s) prepared in the name of Executive Engineer, Swabi Irrigation Division-II. Swabi must be submitted (before the expiry time) electronically along with E-Bid on the EPADS as well as in **sealed envelope** as per KPPRA notification No.S.R.O. (14)/vol;-1-24/2021-22/6058-71, dated 10/05/2022 Notification No.S.R.O. (29)/Vol;1-40/2025-26/699-711, dated 29/10/2025. No Bank cheques or Pay Order shall be accepted. Penalties described in the above mentioned Notification will be imposed in case of non-submission of sealed bid/envelope before the deadline.
4. Electronic bidding shall be done on "Above/Below System" on BOQ/Engineer Estimate based on the MRS/NSI where applicable. Only two digits after the decimal points shall be considered for evaluation purpose. In case of same rates quoted by the contractors, the lowest bidders shall be decided **THROUGH DRAW/TOSS.**
5. The bids will be valid for Ninety days(90) from the bids opening.
6. The Employer has the authority to reject any bid/all the bids by assigning cogent reasons.
7. All the bidders/Firms must be registered with Khyber Pakhtunkhwa Revenue Authority. All the prevailing KPPRA Acts/Rules/Updated instructions/Notification & other Govt; Notifications will be applicable issued from time to time.
8. All the Contractors/Firms shall pay Govt; Taxes including Income Tax, Sales Tax, Professional Tax, Stamps duty etc; as per Govt; Notification circulated from time to time.



9. Successful bidders should sign the Agreement with the Department within 28-days after receipt of Acceptance letter.
10. The Additional security shall be released to the contractor in 04-installment i.e. 1<sup>st</sup> installment of 25% to be released upon completion of 25% of the project. 2<sup>nd</sup> installment of 25% upon completion of 50% of the project. 3<sup>rd</sup> installment of 25% upon completion of 75% of the project & 4<sup>th</sup> installment of 25% after 100% completion/Handing Over the project.
11. All such efforts conspire to curtain making shall be considered as violation of Rules-44 & shall be attributed toward mis-procurement under Rules-54 procurement Rules.
12. Pre-bid meeting will be held on 23/01/2026 at 10.30 AM in the Office of the undersigned.
13. Funds released depend upon the policy of Provincial Government hence payment will be made accordingly subject to availability of funds. Bidders/Contractors agreeing with the financial constraints in respect with payments are as liberty to participate in the bidding as no claim what so-ever will be entertained in this regard.
14. In case of holiday or other un-avoidable circumstances, the Date for opening of Tenders shall be 27/01/2026 with same Terms & Conditions, however the Contractors shall fill their Rates on the above fixed date.
