**Terms & Conditions for E-Bidding: -**

1. Bidders shall upload their bids through the EPADS portal (<https://kp.eprocure.gov.pk>) before the closing date and time. The bid must include scanned copies of the following documents in a single PDF file:

- CNIC
- Valid PEC License
- Enlistment with Irrigation Department, KP
- Active KPRA Registration
- Active FBR Status
- Rate Analysis (if required)

**Note:** It is the sole responsibility of the bidder to ensure that all required documents are correctly uploaded and clearly legible. **Failure to submit any required document, or submission of incomplete, illegible, or corrupted files, shall render the bid non-responsive.**

No hard copies of the bid documents shall be required except for the original Call Deposit Receipt (CDR) for bid security and any additional bid security, if applicable. The CDRs must be issued in favor of Executive Engineer, Swat Irrigation Division-I, Swat, and only CDRs from scheduled banks shall be acceptable. The Procuring Entity shall consider only the documents appearing on the EPADS dashboard at the time of bid opening.

2. Electronic Bidding shall be done on "Above / Below System" on BOQ / Engineer's Estimate, based on the MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
3. The bidder shall submit the original sealed envelope containing the Bid Security (2% of estimated cost) in the form of Call Deposit Receipt (CDR) & additional bid security (if applicable) before the closing date and time.
4. Only Call Deposit Receipts (CDR) of Scheduled Banks shall be acceptable. Bank cheques, pay orders or of Bank guarantee (in case of 2% only) shall not be acceptable.

5. In accordance with KPPRA Notification No. S.R.O (29)Vol:1-40/2025-26 dated 29-10-2025, failure to submit the original bid security CDR and additional CDR (if applicable) in hard form within the stipulated time shall render the bid non- responsive and may result in debarment for a period of one year.
6. All the conditions / instructions given in the bidding documents shall be applicable on all competitive bidders.
7. The bids will be valid for ninety days (90) from the date of bids opening.
8. In case of same rates quoted by the contractors, the lowest bidder shall be decided through draw.
9. Any Bidder who provides incorrect information or failed to submit the original bid security and additional security instruments before the date and shall be liable to dealt with under section 29 of the KPPRA Act read with rule 44 of 2014.

11. Pre-bid meeting will be held on 23/04/2026 in the office of the undersigned at 11.00 AM.
12. All the prevailing KPPRA rules / Act and other Government Notifications will be applicable issued from time to time & will become part of bidding documents.
13. Mandatory conditions as per solicitation bidding documents (SBDs) will be adhered.
14. The Employer has the authority to reject any bid or all the bids assigning cogent reasons.
